

Remote justice? Access to Courts and Tribunals during social distancing

The Coronavirus pandemic and subsequent Government advice on social distancing has led to sudden changes across the Courts and Tribunals system in England and Wales, including a move, in some cases, to remote hearings. PLP launched a questionnaire to capture people's experiences of these changes on 20th March. This event convenes an expert panel to discuss:

- State of play currently in the courts system including an overview of which courts are offering remote hearings, which are suspended
- Issues arising from new guidance on court access and use
- User experiences
- Headline concerns, opportunities and learning
