In times of uncertainty, clarity of purpose, of values and of direction are essential. That is why it was vital to PLP's Board and Executive Team that our strategy be derived from thinking fundamentally about who we are as an organisation, our purpose, our values, and the impact that we feel compelled to make.

In today's volatile and unpredictable environment, we were determined to establish a clear and steady compass – something that could guide us irrespective of which way the winds are blowing – or how hard.

At the heart of this strategy is our purpose: advancing fairness through public law. It is bold and hopeful. It demands that we strive for greater equity and justice no matter the climate.

At the same time, we are acutely aware that hard-won progress can be rapidly lost. We must strengthen and defend human rights and access to justice now and buttress them against future threats. We must be especially focused on working alongside marginalised communities, whose rights and access to justice are too often the first to be further degraded. Our approach must be genuinely strategic. This is not about setting a rigid plan which may shatter on contact with unpredictable developments. It is about equipping our organisation to respond to change, to act with foresight, and to help to shape the future. It is also about empowering and supporting our excellent Executive Team with the flexibility to adapt in order to achieve the most.

At the same time, we have made clear the nature and extent of the impact that we aim for. We will hold ourselves accountable for delivering this, and we encourage others to do likewise.

Since joining PLP, I have been continually inspired by the spirit of collaboration that runs through the organisation. The belief that we achieve most through shared endeavour is embedded in our DNA. It also runs through our strategy. So, this is more than a direction for PLP – it is also an invitation. If you share our sense of purpose and belief in what is possible; if you feel the urgency of defending rights and the conviction that the law is one of our strongest tools for advancing fairness, then we hope you will travel with us as we take this strategy forward.

Public law is society's connective tissue. It binds together the key elements of our democracy and provides the structure for these to work

together effectively. Public law is an expression of respect for each individual, each community, and each institution. It works with and reinforces the principles of the rule of law, human rights and equity.

Public law is fundamental to a fair and inclusive society. At its best, it enables the state to confront and navigate challenging contexts and make well thought through decisions for us all. Where public bodies make decisions that are unlawful, irrational, unfair or contrary to human rights, public law is there to enable people to challenge those decisions and hold the state to account.

This strategy was put together at a time when the case for hope is challenging to make. Marginalised communities are being scapegoated and oppressed, to the point where their lives are being put at risk. We are beset with crises: the climate crisis, increasing poverty, the growing fracturing of society. Across swathes of the country, access to justice is non-existent. Essential state decision-making processes are being carelessly passed on to opaque algorithms. At a time when we need more global leadership, the international world order feels ever more fragile. Domestically, the threat of authoritarianism has reached our shores. If those with authoritarian impulses gain the levers of power, they would have the means to

systemically target marginalised communities and dissolve the principles that underpin a healthy democracy for us all. The stakes are high.

This is not the time to be asking for little, but for doing more. It is the very challenges of this era which demand from us a more hopeful and aspirational vision than PLP has ever had before– one in which the state is not only lawful and fair, but confident and just, capable of securing a fair and inclusive society. I believe striving for this new vision is both vital and achievable. Neither PLP nor any single organisation can be the silver bullet. However, as part of a broader social justice movement that spans generations, it is our responsibility and privilege to take forward the work that others long began.

We wanted a bold strategy that sets the course for us to confront the threats faced by society and centre marginalised communities as we do so. Our work will be underpinned by our values and our principles: striving for equity, sharing expertise, acting with courage and working, as ever, in collaboration.

Together with inspiring clients, partners and collaborators, we must meet this moment head on. No matter the challenges in the years ahead, PLP will advance fairness in society through public law with determination, with authority and with others.

Building on PLP's history

Our strategic development process enabled us to revisit PLP's extraordinary history and reflect on the work of our multi-disciplinary team comprised of casework, research, events and training, policy and advocacy, and communications. We are proud of what we have achieved together with our brilliant partners and clients. This provides a springboard from which to continue to make an impact. Some highlights from recent years include:

- We have been involved in era-defining issues: from working on the prorogation of Parliament case, to safeguarding the promises made to the Windrush generation and dismantling the Rwanda immigration policy.
- We have tackled threats to the rule of law head on: from becoming a leading voice on public sector use of automation and Artificial Intelligence, to tenaciously advocating for and continuing to realise access to justice and defending the Human Rights Act.

We have pioneered new approaches: pooling expertise of all kinds in order to dismantle barriers faced by all marginalised communities, enabling cutting-edge conversations about public law, facilitating extensive collaboration across our network and ensuring our events through to our policy work is grounded in lived and living experience.

Revisiting our history through the lens of using PLP's unique strengths to rise to current challenges made it clear that while PLP has always existed for people experiencing marginalisation, this strategy must go even further to centre them in our work. Some have been directly marginalised by the state and others have been left behind through neglect. We exist for them all. We refer throughout the strategy to "marginalised communities" to keep the document accessible, but we wish to acknowledge here that the individuals and communities for whom PLP exists have breadth of lived and living experience and nuanced circumstances.

Meeting challenges head on

Grounded in a deep and thoughtful analysis of trends and future thinking as well as our history and strengths, this strategy places PLP confidently in an era of escalating challenges, ensuring that we do our part with others to confront them.

We are witnessing a concerning rise of authoritarianism and unaccountable power across the globe. This shift is particularly devastating for marginalised communities, including migrants, who face increasing exclusion from society and find their futures neither guaranteed nor safeguarded. At the same time, we see the rule of law being systematically degraded both domestically and internationally, while power concentrates in the hands of unelected and unaccountable individuals and entities who operate beyond democratic oversight.

These authoritarian tendencies are contributing to a growing fracturing of society itself. Political polarisation has intensified, while respect for fundamental democratic institutions – including Parliament, the state, and the justice system – continues to diminish. Economic marginalisation compounds these challenges, with rising poverty and mounting pressure on public bodies leading to deteriorating public service outcomes for those who need them most. Climate change is a growing threat, and its impact is disproportionately felt by marginalised communities. Communities and individuals face multiple, intersecting disadvantages that create complex barriers to justice and equality. Meanwhile, Artificial Intelligence and automated decision making is proliferating at a rate that is outpacing existing regulatory frameworks, creating fresh opportunities for exploitation and exclusion.

These interconnected challenges demand a coordinated response that that our history demonstrates we are equipped to make; a response that protects the most vulnerable, strengthens democratic institutions, and ensures that power remains accountable to the people it affects.

Our strategy ensures that PLP brings its strengths to contribute to addressing these challenges:

- Rise in authoritarianism & unaccountable power
 - Increased fracturing of society
 - Growing economic marginalisation
 - Rising unfettered use of technology
 - Escalating impact of climate change

CORNERSTONE 1

Advancing and protecting the frontiers of public law

Public law is an integral part of society. It enables the state to make good and fair decisions often in challenging contexts. Where public bodies make decisions that are unlawful, irrational, unfair or contrary to human rights, public law enables people to challenge those decisions and hold the state to account. We will reinforce the role of public law in enabling a fair and inclusive society. We will ensure that public law remains valued and valuable now and long into the future.

We will work to ensure that the state and those with power do not marginalise communities
