JR consultation alert.

The latest statistical assertion made by the MoJ, regarding growth in judicial review claims, questioned by PLP.

On 29 October, the policy team at the Ministry of Justice held a web chat 'to give [those responding to the consultation] an opportunity to comment and ask questions on a proposed package of reforms governing the process of judicial review.'

Richard Mason, Deputy Director – Administrative and Civil Justice, leading on JR reforms responded to a question challenging the MoJ's assertion regarding the rise in civil JR claims as follows:

"... There's actually been a 27% increase in non-immigration and asylum cases - from around 2,300 in 2007 to around 3,000 in 2012..."

To test this assertion, we analysed the complete database from the Administrative Court published here:

We looked at all 12434 issued JRs in 2012, and divided them according to subject matter into three sections: Civil JR, Criminal JR and Immigration/Asylum-related JRs.

We are perplexed as to how the figure of 3000 mentioned above has been arrived at. According to our calculation, and based on the MoJ's own figures and records, we counted 406 criminal JRs and 9868 Immigration/Asylum related JRs. The remaining total for non-immigration related civil JRs is accordingly 2160. This is 840 cases below that claimed by the MoJ.

The table below shows the breakdown of all cases by individual categories, in three sections. Where we were in doubt, we included certain case categories that are already being transferred to tribunals

(or where transfer is likely to happen in the coming year) in the civil JR column. These are: age assessment, immigration detention and naturalisation and citizenship (totalling 99 cases).
